Farm Bureau Members Push for Regulatory Reform

Cook County Farm Bureau® members joined Farm Bureau members from across Illinois to fight for federal regulatory reform. One of Farm Bureau's top federal legislative priorities is regulatory reform. All Americans have an interest in a regulatory process that is transparent, is facts-based, respects the will of Congress and observes the separation of powers in the Constitution.

Earlier this year, the U.S. Environmental Protection Agency (EPA) asked the public's input on which regulations should be repealed, replaced and modified. Cook County Farm Bureau members overwhelmingly mobilized and asked the EPA to tone down the endless list of regulations that farmers face.

Farm Bureau Recommends Policy Changes

Cook County Farm Bureau® has submitted the following policy issues for consideration by Farm Bureau delegates from throughout Illinois:

Policy enabling elected local and state officials having access to a 457 plan rather than a taxpayer-funded pension.

Seven percent of members support elected state and local officials receiving taxpayer-funded pensions. However, 74 percent of farmers responding, support giving elected state and local officials access to a 457 plan.

The second policy supports the absorption, dissolution, disconnection, and consolidation of units of local government by front door referendum.

Over 80 percent of farmer members responding to the 2017 Viewpoint Survey believe that a referendum to

Let's Talk About the Ag on Your Plate

Should I worry about antibiotics in my meat and milk?

All meat and milk products are antibiotic free. On farms like mine, if we need to treat an animal, we observe specific procedures and guidelines to ensure that our animals' health improves and that our meat and milk does not contain antibiotics.

Our milk is tested at our farm before it is shipped for processing. Milk is tested for antibiotics at every stage of the delivery process- at the farm and before it is transported. Each of these tests determine that milk does not contain antibiotics. Milk is tested again for antibiotics before it is packaged or processed into cheese, ice cream, and fluid milk. It's because of these rigorous testing standards that milk is one of the safest food products you can buy.

consolidate or dissolve a unit of local governments should be initiated by the registered voters residing within the unit of government.

Next, over 86 percent of farmer members responding to the 2017 Viewpoint Survey support units of government that go dormant for over two years automatically going before voters to determine if the unit of government should be continued.

The policy supports allowing units of local government that go dormant (no projects or expenditures) for more than two years automatically going before the voters to determine if the unit of local government should continue to be in existence.

The final policy issue addresses scientific studies and supports researchers at publicly-funded institutions being required to release data from all scientific studies in a timely fashion.

Ninety-six percent of farmer members responding to this year's Viewpoint Survey support requiring researchers at publicly-funded institutions being required to release data from all scientific studies in a timely fashion even if they go against popular beliefs.

Farm Bureau members continue to work on policy regarding food labels and misleading information.
